UNIFORM

Our Heavenly Patroness

Mother Teresa of Kolkata, our heavenly patroness, is a catholic nun who served the poorest of the poor worldwide. Born on 26 August 1910 in an Albanian family in Skopje (present capital of North Macedonia), from her very early years she was fascinated by the stories of the lives of missionaries and wanted to become one of them in India. By the age of 12 she was convinced that she should commit herself to religious life. In 1928, at the age of 18 she joined the Sisters of Loreto and in 1929 she arrived in India. She taught in a Loreto school at Kolkata for 20 years. Then in 1946 Teresa experienced what she herself described as "the call within the call to leave the convent and help the poor while living among them". She began her missionary work with the poor in 1948. Clad in a coarse blue bordered white sari, a crucifix pinned at her shoulder, a Bible in hand, with boundless faith and courage, she set about in right earnest serving Jesus in the poorest of the poor.

Her work was appreciated all over the world and was considered a living saint during her life time. The world honoured her with Nobel Prize for Peace in the year 1979. The Catholic Church recognized her saintly virtues and declared her a saint on 4th Sept. 2016. Our School is privileged to have such a great heavenly patroness to inspire us through her love and service for the poor. May St. Mother Teresa our heavenly patroness guide and protect our children and help them in their journey of life.

ST. MOTHER TERESA'S SCHOOL

St. Mother Teresa's school, Bidhuna, is a Catholic Christian Educational Institution run by the St. Thomas Educational and Medical society for the Christian Children. However, we admit any child irrespective of caste, creed, religion or social status. St. Mother Teresa's school intends to shape every child under its roof to a whole-some personality ensuring good character and love for humanity under the able guidance of its dedicated staff.

ADMISSION

Admission to St. Mother Teresa's School is usually in the month of March. A child seeking admission should have completed three years by March 31. The child together with parents is requested to meet the Principal before he/she is admitted. At the time of registration a Birth Certificate from Nagar Palika or Gram Panchayat (for candidates from villages) is to be submitted. The Gram Secretary can issue the certificate for Gram Panchayat. The date of birth and name once entered will not be changed later. The details of Text Books, Curriculum, Evaluation, Syllabus, Uniform, Sports and Games, Co-curricular Activities and Competitions are given in detail in the students Handbook supplied to the children.

FEES

St. Mother Teresa's School receives no Government or private aid and the fees realised from the students is the only source of revenue. To keep up with the rising costs and salary, fees are adjusted from time to time.

RULES REGARDING PAYMENT

All accounts for the term must be settled in full before the beginning of the periodic test. Parents will kindly ensure safe custody of the receipts issued to them in proof of having made the payment.

PARENT-TEACHER MEETING

Parents can meet the teachers every second Saturday. On other occasions parents may be allowed to meet the teachers only with prior permission of the Principal. After each Semester the parents will be called to meet the class teachers, on the date fixed by the school and progress reports of their wards will be issued them. Progress reports and final results will be given only to the parents.
